

"His steadfast love endures forever." Psalm 136

I love the psalms and use them daily in my prayer, in praying with others, in comforting the sick and suffering.

The resounding theme of Psalm 136 is easy to see, as its refrain makes it clear. His steadfast love endures forever. All 26 verses end with these words. It's a reminder to us human beings who are hardwired to believe that his life could come to an end at any time. That is not steadfast love, that is faltering.

This psalm serves as a continual reminder of God's repeated acts of deliverance for his people throughout the ages... and each time we are told WHY the Lord rescued his people "FOR his steadfast love endures forever." He does not deliver us because we deserve it. He does not save us because we impress him. He delivers because this is who he is.
