## St. John's Congregational Council Meeting

## April 15, 2024

**Opening Prayer:** Pastor Seth Jersild opened the meeting with prayer.

Presentation to Richard Moore, Construction Supervisor for McKnight Group: Council thanked Richard for his dedication to excellence as our project supervisor and presented him with a \$5,000 check in recognition for his service above and beyond the scope of his responsibilities for the project.

**Call Meeting to Order, Roll Call:** President Aaron Clark called the April Council meeting to order at 7:11 P.M. Secretary Karen Bentley passed around a sign in sheet for attendance.

**Devotions:** Pastor Seth Jersild lead the devotions titled, "Loving Relationships." Members talked about opportunities and obstacles to meaningful fellowship in our church on Sundays and during the rest of the week.

Additional Agenda Items: Restoration Team formation and the scope of their work-Dan Yeater and Kathy Myers informed Council that St. John's will be blessed with several bequests in the coming months from members who have passed. Some bequests have been designated to go directly to the Endowment Fund-Principal. For a major portion of the bequests, the families have asked that their gifts go to tangible projects to benefit the church or community. As a starting point the Finance Team has identified that it would be appropriate to focus on bringing facilities up to good repair. Dan has agreed to lead a team to analyze, prioritize and plan to address all aspects of the physical structure of our church buildings to make our buildings sound for the next 175+ years of ministry. The team will not focus on cosmetic items. Also serving on the team are: Wayne Beavers, Dennis Imbrock, Doug Grossman, Tom Lang, Butch Myers, Larry Sutton, and Pastor Seth Jersild. As the financial details of the bequests are finalized the team will prepare a proposed plan to present to Council and the congregation. The Finance Team will be developing a robust plan to best utilize the balance of these gifts.

**Recognition of Approval of the Minutes from the March Meeting:** Secretary Karen Bentley reported that a majority of Council members approved the minutes of the March meeting. She will continue to send the minutes by email within 48 hours of each meeting. Members are expected to read the minutes and send Karen an email with their approval/additions/corrections within 48 hours of receiving the minutes. She will amend and resend the minutes as needed.

**Senior Pastor's Report:** Pastor Seth Jersild reported on the following items: a New Member's class took place yesterday. We have a group of people who will be officially joining our church on Sunday, April 21.

175th Anniversary Team: Pastor Seth thanked Carolyn Hartig and Mark Meuser for their excellent work organizing the April 7 concert by The Ohio State University musicians. It was well received by St. John's members and community members.

On Mother's Day, Sunday, May 12, we will have one special combined service at 11:00 in the Sanctuary. This service will commemorate the May 12, 1888 dedication of St. John's. Special music is being planned to enhance the worship service.

Temple Talks-Linda Diehl is conducting video interviews with a variety of members of St. John's. These will be available for viewing throughout the year.

We will be honoring our saints in June & July, including the refurbishment and beautification of the St. John's Cemetery.

Reformation Sunday, October 27 with NALC General Secretary Amy Little as our guest.

Confirmation will be May 19 at the 11:00 Traditional service. There will be a Faith Celebration for the confirmands in the Family Life Center during the Sunday School hour.

Youth Minister Search Team: The team continues to narrow the focus of what we are looking for. They are also assessing candidates to fill this role. Pr. Seth is thankful for the team's passion and dedication to this task.

**Associate Pastor's Report:** Pastor Patti gave several updates. She has also been involved with planning for the 175th Anniversary celebration commemorations including creating a large quilt (9.5' x 9.5') for the wall between the new entrances to the restrooms. She shared the tentative design with Council.

Internship Update: Intern Dale will be graduating from the seminary on May 18. One of his Internship goals is to preach once a month, either at St. John's or another church in the SEOMD. The GriefShare group is meeting weekly. Fourteen people have committed to attending the course. On Sundays, Dale is meeting with the adult SS class in the Fellowship Hall. He meets with Pastor Seth on Fridays to learn about the administrative aspects of the pastoral role.

**Intern Dale Stanley's Report:** Dale told Council how much he valued the opportunity to experience Holy Week and all the various services here at St. John's. He is pleased that the GriefShare class has been well received. He and Pastor Patti have created a schedule for preaching experiences through August.

**Financial Reports:** Treasurer Kathy Myers reported that the Financial Statement for March has not been finalized yet. She will send it to Council as soon as it is finished.

Kathy made a motion to create an investment fund account (similar to the fund that was created for Accessibility Project donations) for the money that comes in from bequests that have not been directed to the Endowment Fund. This fund will have a line on the monthly financial statement like the Accessibility Project did. Paul Wittenberg seconded the motion. The motion passed unanimously.
